• Eligibility Criteria:

As a minimum criterion of eligibility, aspiring candidates are needed to have attained a B.Sc. in any discipline of Life Sciences, Biosciences, M.B.B.S, BDS, BAMS, BHMS, B.Pharm., B.Tech (Biotechnology), or equivalent examination with a minimum aggregate score of 50%.

Important Note:

- As M.Sc. (Medical) programs are in the respective specialties, duration of these programs are of 3 years . The nature of hospital work and other responsibilities are thus more or less same as of a MD registered student. It is therefore, clarified that all those students who wish to register for M.Sc. (Medical) programs will have to follow the same duty roaster along with MD students in respective specialties including night duties or shift duties as applicable.
- Students pursuing M.Sc. (Medical Courses) with MGMIHS have the distinct advantage to continue their career after M.Sc. by registering for PhD at MGMIHS in respective specialty with merit scholarships subject to performance and research work carried out during M.Sc., by following the entrance and other formalities of MGMIHS.
- As per NMC TEQ, M.Sc. (Medical) , PhD. Qualification is eligible for teaching post at Medical Colleges& other Allied Health University colleges.

- **Cancellation Policy for M.Sc. Medical (3 Years) Programmes for the Academic Year 2025– 2026**

This policy is based on UGC Guidelines.

Sr. No.	Points of the time when notice of Cancellation of Admission is received in the Institute	Percentage of refund of fees
1	15 days or more before the formally-notified last date of admission / start of Academic Term	100%
2	Less than 15 days before the formally-notified last date of Admission / start of Academic Term	90%
3	15 days or less, after formally-notified last date of Admission / start of Academic Term	80%

4	30 days or less, but more than 15 days after formally-notified last date of Admission / start of Academic Term	50%
5	More than 30 days after formally-notified last date of Admission / start of Academic Term	0% (No Refund)

Kindly note the following points:-

- Fees once paid not Transferable/ refundable under any circumstances.
- No Cancellation is allowed after these dates. If anybody applies for Cancellation after the admission process, they have to pay the entire tuition fees for 3 years.
- Cancellation of admission should be duly signed by the student and his / her parent / guardian at respective Institute on a plain paper.
- The candidate has to enclose the Admission Letter, Original Fee Receipt and cancelled cheque along with the written application. (State the relation of the 'cheque holder' with student). This is applicable in the period of Cancellation only.
- At the time of admission, full fee of 1st year has to be paid. If for any valid and authentic reason, part payment of fees (Installment OR Fee concession) is agreed upon, then such student will not be allowed to cancel admission under any circumstances. Further such candidates will have to pay the balance fee of 1st year within three months of start of Academic term. Otherwise their provisional admission will be automatically cancelled. It is to be noted that consequences due to part payment in terms of other University requirement will be solely student responsibility.
